

# RULES AND REGULATIONS

## Washington Land Yacht Harbor

**The purpose of these rules is to make this park a pleasant place for you and your neighbors to live. Your cooperation is greatly appreciated.**

- You are allowed to park a recreational vehicle and one companion vehicle at an assigned site. All RV's must be self-contained. Please park any additional vehicles in designated parking area or arrange for use of vehicle storage area.
- Speed limit is 15 miles per hour.
- Quiet hours are from 10:00 PM to 7:00 AM.
- You are responsible for the conduct of your visitors.
- You are expected to keep your site clean and neat.
- Tents are not permitted.
- Trash is to be disposed of in the dumpsters provided. Please use recycle bins on North side of Harmony Hall.
- You are welcome to use the card room, pool room and library in Harmony Hall when the hall is not rented. Those renting Harmony Hall have exclusive use of hall including the bathrooms.
- Parents are responsible for the supervision, conduct and behavior of their children at all times. Children under the age of sixteen (16) must be accompanied by an adult while in Harmony Hall or Gatehouse.
- Vehicle maintenance, oil changes or repairs are not allowed on site. Emergency repairs may be allowed with WLYH management approval.
- Vehicles may only be washed in the designated area at the South end of RV parking area.
- A positive sewer seal is required at both ends of your sewer hose.
- All WLYH facilities are smoke free. Please do not throw cigarette butts on the ground.
- Help keep our restrooms clean. If restroom is in need of attention please notify gatekeeper.
- Off road, all terrain or unlicensed vehicles are not permitted to be ridden in the park.
- Discharging of firearms and fireworks are prohibited.
- No business or commercial activity of any kind shall be conducted on individual sites.
- Pets are permitted with the following restrictions:
  - ✓ Pets must be on a leash and under control of owner when not inside the RV.
  - ✓ Owners are responsible for cleaning up after pets.
  - ✓ Pets, other than service animals, are not allowed in Harmony Hall, gatehouse or grass gathering areas on north and south sides of Harmony Hall.
  - ✓ An off-leash area is available along the west fence in the grove near the RV storage.
  - ✓ Pets may not disturb others with excessive barking or howling.
  - ✓ Pets are not to be tied up to any park property at any time.
- Please do not feed birds or stray animals.
- Soliciting is not permitted. Sales agents are allowed by appointment only.
- We are on a septic system and ask that you do not flush feminine products, sanitary or baby wipes or allow grease or food particles to enter system. Use bleach sparingly.
- Extra vehicles, boats, utility trailers, car dollies and such are not to be parked on site. They may be stored in the RV and Boat storage area under a contract available from the gatekeeper.
- **In the event of an emergency please immediately call 911.** If the emergency does not relate to health or safety please contact Pat at the gatehouse at 360-491-3750
